## NEW JERSEY HOTELIERS SHARING THEIR HARDSHIP

### Neel Parikh – Mt. Laurel Township, NJ

*"We are a proud employer of union jobs, but it will be hard to pay our employees. I have seen some travel organizations hope that there is a Tax credit for employment. We as a travel industry have already had a lot of stress even finding employees due to low unemployment and our wages reflect that. Though now with hardly anyone in our hotel rooms as hotel occupancy drops we worry about paying our bills and retaining employees we have trained and worked with for years"*

### Samir Patel – Columbus, NJ

*"As a hotelier in New Jersey I have experienced firsthand a decline of people renting rooms due to decrease in travel. This has weighed heavy on payroll, maintaining staff, and paying bills. NJ having a high tax on hotel with sales and occupancy tax, this requires high volume of rooms rented to sustain business operations."*

### Rakesh Patel – Bordentown, NJ

*"I have experienced firsthand cancelled reservations and a downturn in revenue. We foresee issues paying basic monthly bills in the coming months of uncertainty. Reduction in occupancy and sales tax or relief from those would be a massive help. Prior to this occupancy taxes in New Jersey are already extremely high and have hurt us as a business over the years. "*

### Sobali Mody – Kenilworth, NJ

*"We as a family own two hotels, The Kenilworth and a Holiday Inn Express in Laurel, MD. We will need to close our NJ hotel temporarily and lay off most of our staff. As a small business, we cannot afford to operate in this environment and staying open also feels like we are part of the problem because we cannot maintain proper social distancing between our employees and our guests."*
